My garden is a tangled mess. I am not one of those careful planners who puts things in nice neat rows. Instead, I get a seed mix of all kinds of random things and I scatter it in my garden beds. What comes up is what I get. I honestly can't always tell what is planted vegetable and what is blown in weed. The squash, cucumbers, and peas climb all over everything. The sunflowers shot up over my head and the tomatoes drowned out the onions and herbs planted

I love the tangled mess. When I go out there, the whole garden hums with multiple pitches as bees, wasps, flies, and butterflies of all shapes and sizes rush around in a pollinating frenzy. Getting brave, I wade into the tangles of vines and the mass of leaves and I will suddenly spot some bean pods or a cucumber – or the greatest joy - a tomato that is red! Each visit to the garden is an adventure.

Sometimes our lives seem like tangled messes too. Maybe we look longingly over at neighbors that seem to have well planted rows in their lives. Yet sometimes even with all the tangles, something wonderful is hiding. Know that God is with us when we are looking at the tangle, shaking our heads in despair and also when we take a breath, dive in and discover a sweet piece of fruit hiding in the mess.

Lena United Methodist Church - Finance Committee Minutes –July 13, 2021

Finance Chair, Kim Nelson called the meeting to order at 6:35 pm and Pastor Keri led us in prayer. Attendees by Zoom: Jeff and Judy Baer. Attendees at the Church: Kim Nelson, Larry Nelson, Richard Holmes, Randy Kryder, Pastor Keri and Chris Bartelt.

The May 11, 2021 meeting minutes were approved.

Kim reviewed the balance sheet, May and June P&Ls and June YTD P&L. Highlights follow:

Balance Sheet as of June 30, 2021: At the end of June, the balance in the General Fund is \$32,079.71. The designated fund balance is \$24,523.94. Comments on balance sheet: We will pay out the Easter collection on July 20 to Le-Win Ministerial Association Benevolent fund and UMCOR. The amount in the Memorials account scholarship fund is \$14,433.69. We will be paying \$4000 from that account in the near future to this year's scholarship recipients.

<u>P&L Reviews</u>- May Profit &Loss comments: We were short on income in May. Income was \$8,721 Budgeted income was \$14,239. To note on trustee expenses: internet expense account is over budgeted amount as one invoice was for two months instead of one. Net ordinary income for May was -\$1740.66.

June Profit & Loss: Income was good in June at \$12,069 against a budgeted income of \$10,392. Under trustee expenses Richard noted that Realgy Energy is no longer our gas supplier beginning in July. Gas will be supplied by Nicor. Net ordinary income was \$3,076.26

June 30, 2021 Year to Date Profit & Loss: Net income was \$2,638.13. Comments: Income for January through June was 74,739.13 which includes the PPP loan of \$12,637. Expense review: in SPRC account we are about \$4800 under budget as we have money budgeted for ministry staffing and we do not presently have a youth minister. Gas bill YTD is over budget due to the large Realgy charge on the March bill.

Other comments:

Kim commented on her "Net Income/Loss Report from 2017 to current" that at the end of 2019 we ended with \$17, 393 in the general fund checking account. In 2020 we received a PPP loan of \$17,800 and this year's PPP loan was \$12,637. If we had not received these extra funds, our general fund checking balance at the end of June would be only \$1,642.71.

Kim said Jodi has submitted the information required to get a credit for the church on the 941 tax form, but we haven't heard anything yet. Judy is going to check on this.

We received a letter from Small Business Administration that the PPP loan for the amount of \$12,637 was forgiven. The forgiveness amount remitted was \$12,637 in principal and \$45.98 in interest; and the forgiveness payment date was June 14, 2021.

We received notice from the Conference that for one of the months July through December 2021 that they will waive the Pastor's health insurance amount of \$1600.

Larry made a motion to adjourn that was seconded by Randy. The meeting adjourned at 6:54 pm.


The meeting closed at 8:35 pm with a prayer by Pastor Keri. The next regular meeting will be September 14, 2021 @ 7 pm.
