#### From the Pastor's Desk....



"When do we have church again?" one of the Kids Night Out participants asked. Without thinking I replied "Sundays at 9 am." I realized as soon as I saw her confused look that I had failed the exam. She didn't want to know when some generic other thing called church was meeting. She wanted to know when THIS gathering of church was happening again. When was THIS group of fun kids, youth and adults going to gather again for a time of joy, celebration, and fellowship.

How easy it is to fall into the trap of a narrow definition of church. I had whole classes in seminary that taught and reminded me not to do it. I often preach reminders to all of us not to do it. Yet, when I got the question, I immediately fell back into old routines and definitions. In that moment my mind heard "church" and thought "a specific gathering at the set hour of 9am on Sunday morning with a set format of worship." Are we doing the same kind of boxing in with our other gatherings?

Jesus always respected the Sabbath. For him that would have been what we call Friday at sundown into Saturday at sundown. Many Christians moved our Sabbath day to Sunday in remembrance of God's recreation and overcoming of death on Easter. The Gospel of Luke records that he went to the synagogue regularly, like we go to church. Yet, as much as Jesus respected the Sabbath, he would not let a narrow definition of it restrict the movement of God's work. Maybe this was because he realized every single day was God's day. Jesus looked for ways to bring Sabbath to other days of the week, and to bring the ordinary into the extraordinary of the Sabbath day.

How can we transform the way we think about our gathering of church? What does it mean for us to be church every day of the week, and to bring our everyday into our times of gathering? May that challenge sit with us this month.

#### Lena United Methodist Church - Finance Committee Minutes - January 11, 2022

Finance Chair, Kim Nelson called the meeting to order at 6:38 pm and Scott Stich led us in prayer. Attendees: Scott Stich, Kim Nelson, Larry Nelson, Richard Holmes, Roberta Rogers, Steve Rothschadl, Judy Buchenau and Chris Bartelt.

The minutes of the November 9 meeting were reviewed and approved.

Kim reviewed the Balance Sheet, November and December P&Ls and December YTD P&L. Highlights follow:

**Balance Sheet as of December 31, 2021:** At the end of December, the balance in the General Fund is \$55,445.80, but would be \$17,253.24 without SBA loans and 941 tax credit in 2020/2021. The designated fund balance is \$40,710.62. Comments on balance sheet: There is \$2,576 in the Thanksgiving account. This will paid out to the Le-Win Food Pantry on January 18<sup>th</sup>. There is \$8151 in the Christmas account at the end of December. There is \$12,383.80 in Undesignated Memorials and the total of the Memorial fund (including checking and CDs) is \$59,674.58. There is \$53,256.04 in the NUDD Endowment fund.

<u>P&L Reviews</u>- **November Profit & Loss comments**: \$11,755 in envelope giving was received against a budget of \$14,239. Total expenses for the month were \$11,236 against a budget of \$11,355.08. Net ordinary income was \$593.40

**December Profit & Loss**: In December, the income from envelope giving was on target (\$14,923 received against a budget of \$14,392). In the Finance account, "Offering Envelopes" was over budget due to ordering offering envelopes for 2022. In the Trustees accounts, the church gas account is over budget (\$actual \$960.08 versus budget of \$830). Trustee expenses for December were under budget by \$73.43. Net ordinary income for the month was \$4,344.53

**December 31, 2021 Year to Date Profit & Loss:** Net ordinary income year to date is \$26,039.42. Comments: Income from envelope giving for January through December was \$143,129. Expense review: in the SPRC accounts, Pastor Health Insurance is under budget as the conference waived the monthly fee of \$1600 in August. Also Pastor Keri only spent \$962.56 of the \$5,000 budgeted for Pastor Professional Expense, and there was no expense in the "Wages – Ministry Staffing" account due to the open position of Children's Ministry leader. Expenses for January through December were \$138,868.27 which is under budget by \$9,225.73.

#### Other comments:

Scott asked how we are doing on the Mustard Seed food pantry collections. Chris reported we have collected and sent checks for \$200 to each of the following pantries: Lena, Cedarville, Warren, Pearl City, and Freeport New Jerusalem Church. We have collected \$36.57 against the \$200 goal for Lanark's pantry. After Lanark, the only remaining pantry we have identified is Dakota/Davis. Kim reported the audit will be done on January 17. Account holders are to have their records turned in to the church office by Friday January 14 for the audit.

The meeting adjourned at 7 pm. Next meeting: March  $8^{th}$  , 2022 @ 6:30 pm.

Kim made a motion that was seconded by Richard to approve the minutes of the November 9, 2021 meeting. The minutes were approved.

Randy Kryder, chairman, arrived at 7:20 pm and presided over the remainder of the meeting,

Committee Reports: Membership – No report Missions: No report.

**Trustees** – Richard reported: tuckpointing at the back of the church will wait until Spring. Cost is about \$3,000. Church eaves trough has been fixed; electrical work in the quilting room and control center is not completed yet. Parsonage siding repairs are done; Pfile plastering was done in December. Painting on the new plaster is completed. One spot for repairing plaster in the Library was missed. Richard will contact Pfile. Elevator inspection was done in December. Dave DeMeester will spray front and side lawns at parsonage this year. Cost is \$41.40 if paid by March 15. Bruce Wuebben has agreed to serve on the trustees committee. Richard will set up a committee to review wireless microphones, rewiring electrical service to the control center, speakers in fellowship hall. The Meeker memorial money could be used for these upgrades. People suggested for this committee are Dean Gerbick, Larry Nelson, Scott Stich, Jeff Stamm. Parking lot needs to be re-coated this year and parking lines painted. Bruce Wuebben will measure and get quotes.

**SPRC** – Lynne reported staff evaluations were completed in December 2021 and rate increases were allotted. There is a job description for the Children's Ministry Director; and the position remains unfilled.

**Lay Leader's Report** — Scott reported the Prairie North Leadership Training is Saturday, January 29 from 9-11:30 am and will be held by Zoom. The training is free. Church members and leaders are encouraged to sign up and attend as there are some informative workshop sessions. Also, the conference-wide Laity Convocation is scheduled for Saturday February 12 from 9 am to noon via Zoom. Cost to attend is \$10.

**Finance** – Scott made a motion that an Ad Hoc committee be set up by Randy. The committee will be comprised of a representative from each of the following committees: Trustees, Finance, Worship, Education, Memorials, The purpose of the committee is to determine best use of memorial monies and bring it before the Ad Council for approval. The committee would meet on an "as needed" basis. The motion was seconded by Lynne and approved by voice vote.

A donation was received in December of \$5,000 to be designated for benevolence to the community. After discussion of various needs and suggestions, Kim made a motion requesting Pastor Keri to contact the Lena Ministerial Association to get a copy of it's Policies and Procedures and Balance Sheet. The motion was seconded by Scott and approved by voice vote.

Kim made a motion to give \$1500 (\$500 for each of the past three years that we haven't donated) to the Lena Area Church Cooperative (LACC). Roberta seconded the motion and it was approved by voice vote.

**Education** — We need a chairman for this committee. Roberta reported Kids Night Out has been very positive. There were 7 attendees in December and 9 attendees in January. The next Kids Night Out is scheduled for February 3 and will have a Valentine's theme.

**Worship** – We need a chairman for this committee. There was no report.

**Pastors Report:** Pastor Keri was on vacation. There was no report.

The meeting adjourned at 8:20 pm. The next meeting will be March  $8^{th}$ , 2022 @ 7 pm.


