From the Pastor's Desk... On September 25th we held a special congregational meeting to consider the congregation's interest in entering into a formal period of discernment about our relationship with the United Methodist Church (UMC). The members present voted to enter into this time of discernment.

Discernment is a way of seeking to understand God's direction for a way forward. In this context, we are seeking to discern if remaining in the UMC or disaffiliating (withdrawing from the denomination) will best enable us to carry out our call to God's ministry. It is a formal process led by our Annual Conference that will be about six-months long and include listening sessions, exploration of our history, values and calling, negotiations, and a special church conference in which a vote of members would be taken to decide if we want to disaffiliate. We will learn more details of what this process will entail soon.

We remain a congregation of the UMC while we are in this period of discernment. We will continue to receive the support and care of our Annual Conference and pastor. We also will remain Christ's church, called to serve the community of Lena. Even as we focus inward for a period to try and discern our future, we continue to be called to shine Christ's light into the world. We still remain a community of love and support for one another, even if we disagree. We will still celebrate joys and lift concerns together. We will still worship, pray, study, and serve together.

The vote on Sunday was divided. Many strong feelings and emotions were shared. Some celebrated the decision, some mourned, and some left confused and uncertain. May God strengthen all of us, no matter where we were on that spectrum. May God give us clarity and hope, and show us how to live out our calling to God's ministry as we spend time together in discernment.

Com Ed will be the new electric supplier for the church.

Organ service contract increased from \$350 to \$400.

Linda K. motioned to continue with the same company out of Iowa. Bruce seconded the motion. Motion carried.

Electric Conduit under the fellowship hall floor is rusted and deteriorated. It will need to be replaced with surface conduit. Richard will get a couple of bids.

Lena United Methodist Church - Finance Committee Minutes -September 13, 2022

Finance Chair, Kim Nelson called the meeting to order at 6:30 pm and Pastor Keri led us in prayer. Attendees: Kim Nelson, Larry Nelson, Richard Holmes, Scott Stich, Randy Kryder Pastor Keri, and Chris Bartelt.

Larry made a motion to approve the minutes of the July 12th meeting. Richard seconded the motion and everyone voted yes to accept the minutes as presented.

Kim reviewed the Net Income/Loss Report stating that through June the general fund checking account was \$38,205.49. If we had not received PPP loans and 941 refund during 2020-21, checking account balance would be \$12.93. Also, year to date income through August 2022 is \$82,049 which is about the same level (\$82,249.41) compared to the same time period in 2019.

Kim reviewed the Balance Sheet, July and August P&Ls and August YTD P&L. Highlights follow:

Balance Sheet as of August 31, 2022: All accounts have been reconciled. At the end of August the balance in the General Fund is \$38,205.49. The designated fund balance is \$29,831.96. The amount in the NUDD endowment fund is \$36,393.04 after parking lot bill was paid. The bus maintenance account only has \$37.82 in it after a recent repair bill was paid. Some donations have come in for the church maintenance account and the balance is at \$4945.65, but there are some projects coming up. In reviewing the memorial funds the music account shows \$1455.06, but should only be \$255.06 as \$1200 was put in the music account, but should have been put in the undesignated memorials account. Special music charge of \$150 for the Butlers was paid out of the music account. There is still money left in the audiovisual memorial account which will be used for security cameras.

P&L Reviews

July Profit & Loss comments: July income was quite a bit different from budget (\$8,546 received against \$12,041 budgeted). In the SPRC account we are under budget due to no one filling the open (youth)Ministry Staffing position. Trustee expenses for the month were under budget by \$29.80 and insurance was paid this month. Net income for July was-\$3,940.85.

August Profit & Loss: Income for August was \$8,894 against the budgeted amount of \$15,051.25 and there were 5 weeks this month. In the Worship account, the copyright license was a little more than the budgeted amount. In the SPRC accounts there was no monthly pastor medical insurance as the conference gave a grant for this, saving \$1600. Total trustee expenses were over budget by \$207.77. Total expenses for the month were under budget by \$2,339.61. Net ordinary income for the month was -\$1,230.06, but would have been -\$2,830.06 if not for the pastor medical insurance grant from the conference.

August 31, 2022 Year to Date Profit & Loss: Income was \$82,049. Comments: Total expenses were \$99,197.15 against a budgeted amount of \$105,447.65 Net ordinary income year to date is -\$17,148.15.

Kim said she will be giving worksheets to all committee chairpersons at the beginning of October to begin planning the 2023 budget.

The meeting adjourned at 7 pm. Next meeting: November 8, 2022 @ 6:30 pm

- **3.** The Council decided the next Mustard Seed collection will go to "Raising Hope" Foster Care Closet in Erie, Illinois.
- **4.** The Council decided the Thanksgiving collection will go to Le-Win Ministerial association. We will decide on the recipient of the Christmas collection at the November meeting.
