Lena United Methodist Church - Finance Committee Minutes –September 14, 2021

Finance Chair, Kim Nelson called the meeting to order at 6:39 pm and Pastor Keri led us in prayer. Attendees by Zoom: Jeff and Judy Baer. Attendees at the Church: Scott Stich, Kim Nelson, Larry Nelson, Richard Holmes, Randy Kryder, Pastor Keri and Chris Bartelt.

Randy made a motion to approve the July 13th meeting minutes and Larry seconded the motion. The minutes were approved by voice vote.

Kim reviewed the balance sheet, July and August P&Ls and August YTD P&L. Highlights follow:

Balance Sheet as of August 31, 2021: At the end of August, the balance in the General Fund is \$53,353.68. The designated fund balance is \$22,050.84. Comments on balance sheet: Easter collection was paid out. The balance sheet shows \$1347 in the Easter fund yet, which is \$1337 to NIC UMCOR plus \$10 Easter donation that came in after check was sent. Kim will check to see if the UMCOR check was cashed. The amount in the Memorials account scholarship fund is \$14,433.69 (the same as when the June balance sheet was reviewed. We paid \$4000 from that account to this year's scholarship recipients. Kim will check to see if the scholarship checks have been cashed.

P&L Reviews- July Profit & Loss comments: We had a very good month on income for the 4-week month of July. Envelope income was \$22,806 versus budgeted amount of \$10,392, due to a couple large contributions. In July, we also received \$7,755.56 which was a credit on 941 withholding. To note on trustee expenses, account 6608 – insurance was zero against a budgeted amount of \$2415, but that is because the insurance was paid in August instead of July. Net ordinary income for July was \$21,762.29.

August Profit & Loss: Income in August was good at \$10,474 from envelope giving against a budgeted income of \$11,392. We also received a \$500 donation from the Quilters. In SPRC expenses we budgeted \$1600 for Pastor Health insurance and the conference waived the insurance fee for that month. Under trustee expenses it was noted that the Water & Sewer bills for July and August were paid in August. Also the church insurance was paid in August instead of July. Net ordinary income for August was \$-414.70

August 31, 2021 Year to Date Profit & Loss: Net income year to date is \$23,985.72. Comments: Income from envelope giving for January through August was \$94,814 which is very close to the budget of \$94,830. Expense review: in SPRC account, expenses are under budget as we have money budgeted for a youth ministry director but don't have one and also Chris was out of the office in June. Gas bill YTD is over budget due to the large charge last winter.

Other comments:

Kim commented on her "Net Income/Loss Report from 2017 to current" that at the end of August 2021 we ended with \$23,985.72 in the general fund checking account. If we hadn't received the PPP loan of \$12,637 and the 941 withholding refund of \$7,755.56 this year our general fund checking balance at the end of August would be only \$3,593.16.

Kim will now begin working with the different committees to complete the 2022 budget which needs to be completed and submitted on line by October 13th and will be approved at the Church Conference on October 27th. The meeting adjourned at 7 pm. Next meeting: November 9th, 2021 @ 6:30 pm.

Committee Reports: Membership – Judy Baer thanked everyone who helped with the “float” entry for the parade. We will put the pictures, that were on the bus, up in the church and also put them in the newsletter and post on the church facebook page. Judy also said they will soon be looking at long term membership to see if there will be a recognition this Fall.

Trustees – Women's bathroom light has been replaced. Pfile can start the plastering in 2-3 weeks. An eavestrough is leaking. Josh Endress will repair the eavestrough. We will also ask Josh to put a downspout on the garage. Dana Keeffer can do the tuckpointing in the back of the church this fall. Cost will be about \$3000. Steve Bonebright will repair parsonage siding. Jr and Lisa Dascher will repair church sign on Hwy 73 south of Lena. Men's group will reimburse them for expenses.

SPRC – Tammy couldn't attend. She emailed her report that September 28th at 6:30 pm the SPRC will be meeting to review job descriptions and salaries and the children's ministry position.

Lay Leader's Report - Scott reported that there will be a Lay Academy on October 16 and 17 at Harvard. Anyone can register and attend. Chris will add the information to the church newsletter. Lay Sunday at Lena UMC will be on October 17. The service will be handled by all lay people.

Finance – Finance reports were covered at the Finance Meeting earlier tonight. Kim will be working with the different committees to develop the 2022 budget.

Education – A special meeting was held August 10 with low turnout. It was determined at that meeting to have a special service on August 22 in Fellowship Hall and involve the entire congregation. Outcome of the August 22 service:

Pastors Report: - Pastor Keri reported she is in the process of ordination work. Her paperwork is due in January 2022 and interviews will be held in March. If anyone has shut-ins or elderly family who would like a Pastoral Visit, please contact the church office or Pastor Keri and she will visit them. Chris will note this in the bulletin announcements. The Council decided the Mustard Seed collection in process will go to Tyler's Justice Center. We will decide on recipients of Thanksgiving and Christmas collections at the next meeting.

The meeting closed at 8:26 pm with a prayer by Pastor Keri. The next meeting will be November 9, 2021 @ 7 pm.


